Documents to be submitted for shareholder's request for documents

- 1. Application for shareholder's request for documents signed by securities holder.
- 2. If change name/ surname, please attach a copy of the certificate showing a change of name or surname or marriage or divorce certificate as the case mav be.
- 3. The fee can be paid in cash. In case of submitting request via postal service, or a copy of statement transferred to the account named Thailand Securities Depository Co., Ltd., Siam Commercial Bank, Vithayu Branch, saving account no. 049-2-63596-6.
- 4. Identification documents, according to the type of person. In case of other individuals, please contact SET Contact Center as shown at the bottom of the form.
- 5. If the securities holder has deceased, attach the following documents certified true with an original signature of the estate administrator:
 - A copy of the court decree appointing the administrator of the inherited estate and certificate final judgment, certified within the past 12 months before being submitted to TSD.
 - A copy of the deceased securities holder's death certificate
 - A copy of the person's Thai national I.D. card of the estate administrator.

	by an authorized official of the juristic person or the government agency having jurisdiction over the juristic person.

	All documents for "Other Nationalities" above, must have been :
	(1) The notary public or any competent authority in the country where such documents were prepared or certified correct,
	shall certify the signature of the person who prepared such documents, or who certified the accuracy of such documents.
	(2) An official of the Thai Embassy or Thai Consulate in the country where such documents were prepared or certified correct,
	shall certify the signature and the seal of the notary public or any other authority which performed the act under (1).
	(3) Certified within the past 6 months before being submitted to TSD.
	(4) Translated into English if necessary.

Remarks: Securities holder who has deposited the securities with broker/custodian can submit a request for the securities holder list as at Record date "RD"/Book Closing date "BC". The details are as follows:

- Submit Shareholder's request form: "Shareholder's request for documents" and Identification documents, only on RD or BC.
- In case of submitting document by postal mail, the request date to use is the postmark date, which must match the RD or BC. 2.
- Only the Securities holder whose name appears in the securities on RD or BC, can request the securities holder list as at RD or BC.
